- 1. Post doctoral trainees without a health professional degree:
  - o Stipend: \$40,000 + a \$5,000 research allowance per annum
  - Maximum duration: 3 years
- 2. Post graduate health professionals trainees (including post doctoral trainees):
  - who hold or are able to hold licensure (full or educational) in Canada and have completed no more than two years of research or clinical training since obtaining their health professional degree:
    - o Stipend: \$40,000 + \$5,000 research allowance per annum
    - Maximum duration: 4 to 5 years (depending upon whether a PhD is being pursued, no PhD = 4 years maximum)
    - Note: Should a trainee in this category complete more two years of research or clinical training since obtaining their health professional degree during the tenure of the award, this trainee's stipend would be increased to \$50,000.
  - who hold or are able to hold licensure (full or educational) in Canada and have completed a
    minimum of two years of research or clinical training since obtaining their health professional
    degree:
    - Stipend: \$50,000 + \$5,000 research allowance per annum
    - Maximum duration: 5 years

NOTE: If two or more applicants fall within the research area of a particular partner, the partner is required to fund the application having the highest score regardless of stipend level.

## New Investigator award:
